He is a Professor of Civil Procedure and International Arbitration Law at the Democritus University of Thrace. Professor Calavros heads the litigation and dispute resolution department of the Firm. He specialises in national and international litigation and arbitration. He has been a member of the drafting committee which has revised Greek Civil Procedure Code.

Prof. Calavros studied law at the School of Law, University of Athens where he was awarded his LLB (Ptychion) with Distinction (9, 10/11).

He was admitted doctor iuris utriusque by the Law School of the University of Würzburg, Germany (summa cum laude).

He has also followed classes of civil law and civil procedure law at the Universities of Caen (France) and Geneva (Switzerland) and classes of comparative private law at the University of Strasbourg (France).

Prof. Calavros has been Professor of Civil Procedure Law at the Democritus University of Thrace, School of Law since 1982; prior to that he taught civil law (*i.e. general principles of civil law, law of contracts, non performance of contracts*) and civil procedure (*i.e. general part, Injunction procedures, enforcement of decisions*) at the University of Würzburg (Germany).

Prof. Calavros has research interests in the civil procedure law and the law of arbitration of Greece, EU and other countries. He is actively involved in research on many aspects of civil procedure policy and regulation as well as arbitration concerned matters.
